

**THE COUNT'S HALLOWEEN SPOOKTACULAR 2020
COSTUME CONTEST OFFICIAL RULES - PARK ADMISSION NECESSARY**

1. To enter, come to Sesame Place, 100 Sesame Road, Langhorne, Pa on October 31, 2020. Contest is open only to citizens and legal permanent residents of the 50 United States and the District of Columbia (excluding the state of Arizona). Contest is void where prohibited. Contest is open to all ages. Adults (individuals age 18 and older) may not enter best child category. Any costume, which in the judges opinion is considered offensive or in poor taste, or does not meet any other pre-requisite for entry will be considered ineligible.
2. Registration will take place on Oct. 31, 2020. Registration begins at 10:00am at the registration table in the Plaza area of the park. The Child Costume contest will be limited to the first 70 children to register. The Family Costume Contest will be limited to the first 30 families to register. Contest will be held in Sesame Place Neighborhood Theater at the following times: Child Costume Contest: 1:00pm; Family Costume Contest: 2:00pm. A family is defined as a group of 2 or more consisting of at least one child under the age of 18 and one parent or legal guardian.
3. For a copy of the rules, send a self addressed stamped envelope to: Sesame Place Costume Contest, 100 Sesame Road, Langhorne, PA 19047. Requests must be received by end of business day November 9th, 2020.
4. All contestants over the age of 2 are required to wear face coverings to participate in the contest. Failure to wear a face covering may result in disqualification from the contest. In a family, all family members over the age of 2 are required to wear a face covering to participate in the contest. Failure to wear a mask by as little as one person in a family may result in the entire family being disqualified from the contest.
5. Costumes will be judged on Oct. 31, 2020 by a panel of judges, based on the judges' personal assessment of; creativity (33.33%), execution (33.33%) and audience appeal (33.33%). In case of a tie, tied entries will be based solely on creativity. Bonus points are possible if face coverings are themed with the costume. Six winners will be chosen, 3 from each category in 1st, 2nd and 3rd placements. Categories include Best Child and Best Family. Potential winners will be notified on the day of the event. Decisions of the judges are final and binding. Winners may not substitute or transfer prize but Sponsor (defined in Section 12 below) reserves the right to substitute prize with a prize of equal or greater value.
6. Prizes will be awarded. Potential winners may be required to complete, sign and return an affidavit of eligibility and liability and publicity release within 5 days of prize notification. In the event of noncompliance within this time period, prize will be forfeited and an alternative winner will be selected. Any prize notification or prize returned to the Sponsor or its agencies as undeliverable will result in disqualification and the awarding of that prize to an alternate winner. **AN ENTRANT IS NOT A WINNER OF ANY PRIZE UNLESS AND UNTIL ENTRANT'S ELIGIBILITY HAS BEEN VERIFIED. 7. Potential winners will be announced on the day of the event approximately five to ten minutes after the completion each contest. They will be posted at The Welcome Center and at Sesame Place Neighborhood Theater by 3:15pm. Contest entrants should remain in Sesame Place Neighborhood Theater after each contest to hear the winners of that category.
8. Employees and immediate family members of employees of Sponsor, Sesame Place, Sesame Workshop, and their affiliates, subsidiaries, advertising and publicity agencies are ineligible. This contest is void where prohibited by law, and is subject to federal, state, and local regulations. Taxes on prizes, if any, are solely the responsibility of the winner.
9. Acceptance of prize offered constitutes permission to use winner's name, biographical information, and/or likeness for purposes of advertising and promotion without further compensations permitted by law.
